# Subject : Outcome of the Meeting of Board of Directors of Surani Steel Tubes Limited ("the Company") pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Dear Sir/Ma'am,

With reference to the captioned subject and pursuant to the provisions of Regulation 30 read with Part A of Schedule III, of the Listing Regulations, we hereby inform your good office that the Board of Directors of the Company at their Board Meeting held today i.e. on May 10, 2023 **inter-alia** considered and approved the following businesses:

## 1. <u>Increase in Authorized Share Capital and consequent alteration of the Capital Clause in the</u> <u>Memorandum of Association of the Company</u>

Approved the increase and alteration of the Authorized Share Capital of the Company from Rs. 9,00,000/- (Rupees Nine Crore Only) divided into 90,00,000 (Ninety Lakhs) Equity Shares of Rs. 10/- each to Rs. 20,00,00,000/- (Rupees Twenty Crores Only) divided into 2,00,00,000 (Two Crores) Equity Shares of Rs. 10/- each.

Such increase and alteration in the Authorized Share Capital of the Company will require consequent amendment in the Capital Clause (Clause V) of Memorandum of Association of the Company, subject to approval of the shareholders of the Company

### 2. Issue & Allotment of upto 80,52,000 Fully Convertible Warrants ("Warrants") on Preferential Basis.

Issue & Allotment of upto 80,52,000 (Eighty Lakhs Fifty Two Thousand Only) Fully Convertible Warrants ("Warrants") carrying a right exercisable by the Warrant holder to subscribe to one Equity Share per Warrant, to persons belonging to 'Non-Promoter' Category, on preferential basis, at an issue price of Rs. 135/- (Rupees One Hundred Thirty Five Only) per warrant in accordance with provisions of Chapter V of SEBI ICDR Regulations, for an aggregate amount of upto Rs. 1,08,70,20,000/- (Rupees One Hundred Eight Crores Seventy Lakhs and Twenty Thousand Only ) for Cash to be convertible at the option of the warrant holder in one or more tranches within 18 months from the date of allotment, subject to the approval of shareholders and other statutory approvals.
